PURPOSE AND OUTCOME

Course Overview

As an introductory course, many of the broad concepts and skills of management will be covered. Students will learn the application of these techniques to health service organizations (HSOs). In addition, students will begin to understand the variability of management styles and personalities and develop their styles.

Course Objectives and Goals

Upon completion of the course, students are expected to be able to,

1. Understand the fundamental principles of management.
2. Discuss the current healthcare environment in which health services organizations operate.
2. Distinguish between the core functions of healthcare management, including strategy, marketing, controlling, and organizational design.
3. Clarify distinctions between leadership and management.
4. Accept the value of applying Emotional Intelligence principles to professional success.
5. Break down and describe the interrelationships between the fundamental departments of health services organizations and their contribution to the organizational mission

Instructional Methods

Readings, lectures, case studies, and client-based projects are the primary learning tools. The benefits you receive from this course are directly related to your class preparation and participation- in other words, to the effort you put into the course.

Exam

This course has two exams: Exam 1 and Exam 2. Exam dates are given on the course schedule. Exams cover the course materials, including lectures and readings. Exam 2 is not cumulative. Both exams will comprise multiple choices, true/false, matching, and short answer questions.

Multiple homework assignments will be assigned throughout the semester.

Recording Class Lectures

"Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. The only allowable purposes are (1) for personal educational use, (2) in connection with a complaint to the university, or (3) as evidence in, or in preparation for, a criminal or civil proceeding. All other purposes are prohibited. Specifically, students may not publish recorded lectures without the written consent of the instructor.

A "class lecture" is an educational presentation intended to inform or teach enrolled students about a particular subject, including any instructor-led discussions that form part of the presentation, and delivered by any instructor hired or appointed by the University, or by a guest instructor, as part of a University of Florida course. A class lecture does not include lab sessions, student presentations, clinical presentations such as patient history, academic exercises involving solely student participation, assessments (quizzes, tests, exams), field trips, private conversations between students in the class or between a student and the faculty or lecturer during a class session.

Publication without permission of the instructor is prohibited. To "publish" means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code."
