<b>Course Title:</b>	SPA6936- Autism Spectrum Disorder (ASD) & Augmentative and Alternative Communication (AAC)

**Course Description:**

This graduate level course will provide a strong foundation in clinical, practical, and theoretical information regarding AAC and ASD across the lifespan. ASD is characterized by social-interaction difficulties, communication challenges, and behavioral differences. Prevalence, based on how it's defined, is as high as 1 in 59 children. Because of this, as a speech-language pathologist, a portion of your caseload will be composed of individuals with ASD. This graduate level course will provide a foundation in the client-centered and evidence-based evaluation and treatment of ASD as provided by aspirant speech-language pathologists.

In the U.S, about 4 million Americans aren't able to rely on natural speech to meet basic human communication needs. This course will provide foundational knowledge and skills in service delivery for individuals using AAC. You will learn the key principles and procedures regarding the assessment and intervention (aided and unaided) related to AAC, engage in hands-on learning with various low tech and high tech AAC, complete simulations in AAC, and apply clinical skills and knowledge to case studies in AAC.

At the end of this semester, you will have the knowledge and skills needed to provide culturally-responsive, evidence-based care to individuals with ASD and individuals using AAC, including:

1. Understanding the diagnostic requirements for ASD in educational and medical settings.

2. Select appropriate assessment materials for use in the evaluation of speech, language, cognition, and overall communication in individuals on the autism spectrum and/or individuals that require AAC.
3. Support the inclusion of speech-language pathologists as integral members of an interdisciplinary team that evaluates for autism spectrum disorder.
4. Discuss the benefits of using AAC for individuals with communication disorders.
5. Compare and contrast the features of various AAC systems
6. Apply knowledge and skills in the assessment and intervention of individuals with ASD and individuals who use AAC to clinical cases in speech pathology.
7. Defend the strengths and weaknesses of common treatment options for individuals with autism spectrum disorder.
8. Design appropriate treatment activities that correlate to a treatment plan for individuals with autism spectrum disorder and individuals using a communication device.
9. Employ client-centered care and evidence-based practice when delivering services to individuals with ASD and individuals using AAC.
