## PURPOSE AND OUTCOME

### Course Overview

This course is designed to provide students with knowledge and an understanding of the importance of management and leadership in public health organizations. We will work together to foster an overall sense of belonging, encourage diversity of views and perspectives, and leverage each person's uniqueness to the class. Together, we will create an inclusive climate that allows all of us to do our best work in a safe environment.

### Course Goals and Objectives

Upon successful completion of the course, students will be able to:

1. Appraise the importance and application of management and leadership principles as core public health concepts.
2. Identify, evaluate, and apply concepts, methods, and tools of public health data collection, use, and analysis to public health cases.
3. Develop a proposal for an intervention that addresses a population health challenge by applying concepts of population health, basic processes, approaches, and interventions that address the major health-related needs and concerns of populations.
4. Apply leadership and managerial methods to evaluate socio-economic, behavioral, biological, environmental, and other factors that impact human health and contribute to health disparities.
5. Identify concepts and create a portfolio of products using project planning, assessment, evaluation, and implementation tools.
6. Discuss the ethical, economic, and regulatory dimensions of leadership in health care and public health policy, and the roles, influences, and responsibilities of the different agencies and branches of government.
7. Apply principles and concepts of public health leadership and management to produce public health-specific communication, including technical and professional writing and the use of electronic technology.

### Instructional Methods

PHC 4117 is a blended learning class combining synchronous, in-person lecture and discussion components and an online, asynchronous component. Students are expected to complete online activities PRIOR to class meetings to prepare for the in-person activities and discussions.

### Blended Learning

*What is blended learning, and why is it important?*

A Blended Learning class uses a mixture of technology and face-to-face instruction (via Zoom) to help you maximize your learning. Knowledge content that, as the instructor, I would have traditionally presented during a live class lecture is instead provided online before the live class takes place. This lets me focus my face-to-

face teaching on course activities designed to help you strengthen higher-order thinking skills such as critical thinking, problem-solving, and collaboration. Competency in these skills is critical for today's health professionals.

*What is expected of you?*

You are expected to actively engage in the course throughout the semester. You must come to class prepared by completing all out-of-class assignments. This preparation gives you the knowledge or practice needed to engage in higher levels of learning during the live class sessions. If you are not prepared for the face-to-face sessions, you may struggle to keep pace with the activities occurring in the live sessions, and it is unlikely that you will reach the higher learning goals of the course. Similarly, you are expected to actively participate in the live class. Your participation fosters a rich course experience for you and your peers, facilitating the overall mastery of the course objectives.

## ACADEMIC REQUIREMENTS AND GRADING

### Assignments

**Quizzes** will be administered in class (during the first hour) or outside of class. Having quizzes regularly encourages studying the material on a regular basis and paying attention to the material covered in class. Having more quizzes can reduce test anxiety, and doing poorly on a single quiz will have a negative effect on a student's grade. The lowest **two** quizzes will be dropped, which is generous because missed in-class quizzes are dropped automatically. If a student is absent during an in-class quiz, the grade is recorded as zero and counts as one of their dropped quiz grades. The dropped quiz policy is not intended as a way for students to improve their overall grades. The policy is in place because we understand that students might miss a class for various reasons, and anyone can have a bad day. Quizzes will consist of true/false, multiple-choice, or short-answer questions probing the content of that week's materials and/or readings. The first quiz will be a formative assessment of the specifics of the syllabus. Formative assessments are not graded but are designed to measure misconceptions, learning gaps, and clarification areas. Most quizzes will be summative assessments evaluating your learning, knowledge, and proficiency. Disallowed aids during a summative assessment include but are not limited to class notes, books, online resources, phones, or other people. Students may not discuss any aspect of a quiz with classmates or others until the due date/time has passed. Potential schedule conflicts preventing a student from completing a quiz by the due date should be reported to the TA as soon as possible before the quiz becomes available on the course website. Any technical issues should be reported via e-mail to the TA before the quiz end date/time. Make-up quizzes due to technical difficulties will not be considered otherwise.

**Discussion posts** will be formulated as interview questions and allow students to self-reflect on their goals, strengths, and leadership skills. Posts are due by 11:59 a.m. on Sundays preceding the class meeting time. Like the quizzes, **two** discussion posts can be skipped or dropped off without penalty.

**Leadership tip** assignment will provide the students with an opportunity to learn about a leadership topic of interest, create a research and practice-based summary, and share it with the class (presentation dates will be assigned during the second week of class, after drop/add). A list of potential topics will be provided in

class, but students can also pick other topics. Students will research the chosen topic and include at least two (2) research articles and two (2) practitioner articles. For this assignment, students will prepare a one-page (1) Leadership Tip summary handout that includes (1) key definitions, (2) research and practice evidence, and (3) action points. Executive summaries will be shared with the class as discussion posts. Students will also present their tips at an assigned time in class; presentations will be limited to four minutes plus 2 minutes of Q&A and can (but don't have to) be accompanied by a one-slide presentation. Executive summary (as a discussion post) and any presentation materials (by email to the instructor) must be submitted by 11:59 am (noon) on Sunday preceding the class meeting time.

**Leadership theories presentation** is a team assignment that will allow students to practice developing and presenting educational materials. These presentations also make portfolio products that can showcase students' competencies as emerging public health leaders. Teams of 3-4 students will be randomly created during the second week (after add/drop) to develop a video or a blog post about one of the leadership theories covered in this class. The team's task is to record a 10-minute presentation of the leadership style OR write a 1,000-word blog-style post. More information about the required content and grading criteria will be provided on Canvas. The video or blog must be uploaded to Canvas by 11:59 am (noon) on Sunday, 2/16.

**Public health challenge case report** will be assigned in lieu of the mid-term exam. The case will be completed as a team assignment and submitted by the end of class on 3/11. Students will receive information and additional guidance on the case assignments three weeks before the due date.

**Research poster** assignment will provide students the opportunity to practice synthesizing and translating scientific evidence for presentation. Engagement in research is highly valued by the graduate school admission committees, and this assignment will provide the students with an opportunity to practice science communication skills. Students will work in teams to develop posters based on the public health challenge case reports. Alternatively, students can petition to the instructor to use their own projects (e.g., honors thesis, research volunteering, prior course written assignments) or published academic papers to develop a 250-word abstract and poster. Abstract and poster templates and examples will be provided on Canvas. Both abstract and poster must be uploaded to Canvas as two separate PDF files to by 11:59 am (noon) on Sunday, **TBD (due date will be coordinated with the PPHP Research Days submission deadline).**

**Leadership portfolio** assignment will allow the students to develop and submit a portfolio that includes their resume, cover letter, strengths and leadership statement, and an example of one of the course products (assignments or in-class activities) with a reflection on how the assignment product represents the development of the student's professional skills. The portfolio must be uploaded to Canvas by 11:59 am (noon) on Sunday, 4/20.

**Public health leadership essay** will be assigned in lieu of the final exam. This individual assignment will follow the guidelines of the [Richard J. Stull Student Essay Competition in Healthcare Management](#). The assignment will be due by the end of class on 4/29. Students will receive information and additional guidance on the case assignments three weeks before the due date.

**Team peer evaluation** will be provided by each student to evaluate team members on their availability and willingness to contribute to the team assignments, as well as the quality of those contributions. Individual evaluation scores will be kept confidential and will be viewed only by the instructor and the TA. **STUDENTS WHO DO NOT SUBMIT A PEER EVALUATION WILL RECEIVE 0 POINTS, EVEN IF THEIR TEAMMATES EVALUATE THEM.**

### **Recording Within the Course**

Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. The only allowable purposes are (1) for personal educational use, (2) in connection with a complaint to the university, or (3) as evidence in, or in preparation for, a criminal or civil proceeding. All other purposes are prohibited. Specifically, students may not publish recorded lectures without the written consent of the instructor.

A “class lecture” is an educational presentation intended to inform or teach enrolled students about a particular subject, including any instructor-led discussions that form part of the presentation, and delivered by any instructor hired or appointed by the University, or by a guest instructor, as part of a University of Florida course. A class lecture does not include lab sessions, student presentations, clinical presentations such as patient history, academic exercises involving solely student participation, assessments (quizzes, tests, exams), field trips, private conversations between students in the class or between a student and the faculty or lecturer during a class session.

Publication without permission of the instructor is prohibited. To “publish” means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
