PURPOSE AND OUTCOME

Course Overview: The influence of participation in life's activities (i.e., self-care, work, play school, etc.) and its impact on health of persons with and without disabilities across cultures will be analyzed throughout the lifespan. Small group projects with students from South Africa will enhance multicultural perspectives and cultural competency.

Relation to Program Outcomes: Participation in life's activities such as self-care, work and play, can be used to facilitate improved health outcomes in people with and without disease and chronic conditions. Individuals working in the healthcare or educational environments will acquire an understanding and appreciation of the use of life's activities in populations with physical and cognitive limitations across cultures. Students will work collaboratively in small groups to determine how body impairment impacts engagement in activity and how cultural and personal factors interact in those with and without disability. Individually, students will explore a new activity (i.e., new occupation) while investigating how their participation affects personal growth and development.

Course Objectives and/or Goals:

1. Define terms such as occupation, occupational imbalance, occupational shifts, occupational deprivation, occupational justice, adaptation, role strain, activities of daily living (ADL), instrumental activities of daily living (IADL), lifestyle redesign, cultural competency, cultural humility, cultural intelligence, culturally and linguistically appropriate services (CLAS), health literacy, and use correctly in weekly discussion posts and all other written assignments.
2. Discuss specific occupation engagement by people with and without disabilities across the lifespan and across cultures. Identify common themes of occupation in various parts of the world. Express sensitivity and respect for cultural differences and openness when discussing occupation selection.
3. Identify ways in which culture determines occupation by working with South African graduate students on a project via Zoom. Describe areas of commonality and difference with your

background (i.e., values, beliefs, traditions, education) and those students living in South Africa. . Demonstrate respect and openness in your interactions.

4. Conduct an activity analysis on pre-determined occupations (tooth brushing and driving) and outline methods of modifying activity for an individual with a cognitive or mobility impairment. Describe how culture impacts these activities.
5. Describe how occupation may influence health across the lifespan and analyze the ways that cultural views, opinions and differences may impact participation and well-being.
6. Participate in a new occupation (e.g., art, sport, healthy habits, language acquisition, musical instrument exploration, ADL, IADL, practicing/establishing a tradition from another country, etc.) and identify the reason for selection and method of learning. List at least two S.M.A.R.T. goals and whether these were accomplished over the semester. Discuss the effect of occupational engagement on your personal growth and health.

ACADEMIC REQUIREMENTS AND GRADING

Assignments: *All turned-in assignments will employ proper grammar and spelling, appear aesthetically pleasing and professional, and address all questions posed to obtain maximum points.*

You can be concise yet thorough simultaneously. Please use APA style for any citations from academic journals. It is acceptable to provide links for references if from a web page.

Pie charts: Via 4 separate pie charts, identify categories of presumed or actual occupations -e.g., select categories such as ADLs, leisure, studying/class, work, etc.-whatever large chunks of time you can categorize for a 24-hour period. You may have other categories- whatever portrays best your daily activity. These are the 4 different pie charts to create: 1) how you currently spend your day as a college student 2) how you spent time as an elementary school student 3) how a person over 65 might spend the day (may choose how active or inactive this person is but relatively healthy) and 4) how someone with a severe disability (of any **age** and any **disability** and **country** other than US- you decide) from another country might spend the day (may need to do some research on this or base on someone you know). Submit to Canvas by 7/8. (10 points)

Group project with Durban, South Africa: You will work with students from South Africa (Durban University of Technology- DUT) who are in a graduate employee health nursing program. Prompts will be given during class and you will work with a group to respond. Responses will be shared during the larger group discussion. After each ZOOM session, think about what your group discussed and write your daily reflection using a diary or journaling format. Please refer to rubric in Canvas for specific details on how to complete this project. **Due dates: Reflection 1: 7/10; Reflection 2: 7/17; Reflection 3: 7/24** (total: 25 points)

RESEARCH: Part of this virtual exchange project will allow us to look at student attitudes. Please read the Research Participant? Canvas announcement and the brief Informed Consent Form (ICF) to determine if you would like to participate by answering survey questions during class time. Be honest about your feelings before we start the exchange and at the end. We may use samples from your reflection pieces in future poster presentations or publications. No identifiable information will be used in order to protect your privacy. The goal is to improve or modify this experience for future students and to share with other educators. This is a voluntary activity and no points are associated with research participation.

Activity analysis: This is a GROUP activity for BOTH activities. Make sure you plan ahead so that all group members can contribute. Using the provided activity analysis template as a guide on Canvas, break down the component parts of a selected activity- add any categories that are appropriate to the template. Activity analysis will be covered in various ways and one ungraded analysis will assist in skill development (e.g., tooth brushing due on 7/18/25). Regarding the **graded** analysis: Each group will be assigned a particular country and disability. Analyze how the occupation of driving could be modified to enable individuals with cognitive impairment and/or mobility impairment to participate. Include the impact that culture and country may have on this IADL. Refer to the rubric for specifics and grading criteria. Turn in driving analysis to Canvas on 8/1/25. (35 points)

Participation: Various short activities will complement the topics of the week. Online participation is defined as: attending office hours the first week to have occupation trial approved; meeting all deadlines for weekly assignments; attending Zoom sessions on 7/8, 7/15. & 7/22 with DUT students. You will get participation points each week- 8 points each for weeks 1-5 and 10 points for week 6 (total of 50 points).

Quizzes: To provide background and context for weekly topics, weekly quizzes comprising of 10 questions (1 point per question) will be given concerning major concepts covered in the weekly readings and weekly module videos. Please use Canvas to access the quiz of the week. Quizzes are to be taken generally by Monday at 11:59 pm (will open on Thursday afternoon for the following week's quiz). The first week's quiz is an exception and is due on **7/3/25**. LockDown browser will be used for all the quizzes. Please take LockDown practice quiz before taking syllabus quiz (found in the Quizzes tab on Canvas). **Syllabus quiz is due on 7/2/25.** (Total of all quizzes: 50 points)

Discussions: Each week has prompts regarding cultural aspects of occupation. Small groups have been randomly identified to facilitate reflection regarding the specific prompts of the week. Students will individually respond to the prompts and will react to at least one other person's comments to receive full credit. Remember that a substantive response is needed which requires reflection AND thoughtful reaction to other perspectives. The response should incorporate material from readings and videos and be concise but thorough. To allow everyone time to reply to prompts, the Discussion page will open on Sundays and close at 8:00 pm on Wednesdays. **The exception is week 6 when the deadline is Sunday, 8/3 at 8:00 pm** and opens up earlier. It is emphasized that an exemplary post will demonstrate content learned from readings, videos (all types- instructor created, assigned and optional) mixed with your reflection and reaction to another group member's post. Including course information in your posts will demonstrate integration of content. (Total: 50 points)

Occupation exploration: Choose a **new** occupation that is of particular interest to you (it is a requirement for you to check with instructor before beginning via office hours or e-mail by **7/5/25**) and plan on spending 3-5 days a week for **at least 3 hours per week** for 4+ weeks exploring the activity (i.e., researching rules/guidelines/information; taking classes; reading books, articles, online training; trying out the activity and experimenting; blogging or making diary entries about the process; documenting time spent in various parts of occupation). Set at least 2-3 measurable goals (SMART goals) to track progress and discuss if you met goals or not and why. Demonstrate and/or discuss your new occupation with your classmates via a recorded video due 8/6@11:59 pm. Discussion/demonstration to be ~10 minutes in length and should provide the class with the details of engaging in the new occupation (via demonstration, explicit discussion, and proof of your engagement) and the goal outcomes. Recall that the occupation trial has several parts (video demonstration, goals, weekly log) and all are due by 8/6@ 11:59 pm but can be uploaded earlier. This gives me time to grade your projects during the week AND you can share your video of your new occupation with others. It is preferred that you use the Canvas option to create your video which is outlined in the Canvas announcement (Total: 80 points).

Expectations Regarding Course Behavior

This is an intensive course that will cover multiple topics weekly and include small group projects and discussions to facilitate a wide range of perspectives and occupation exploration. Access to a laptop, iPad or computer is expected. Students are required typically to take the weekly quiz by Monday at 11:59 pm (except for the first week). Quizzes are NOT open book.

Weekly assignments will require students to work with others on small projects or respond to discussion prompts. Remember to respect the opinions of others and treat classmates the way that you would like to be treated. Openness and tolerance of differences is expected and will be maintained so that growth can occur. Entering the health professions requires not only skill competence but the utilization of active listening skills, patience, a pleasant and professional demeanor while giving utmost respect to others who are experiencing health problems/challenges. If these behaviors are not displayed online or on ZOOM, I will speak individually to those who are having challenges and we will devise an action plan for improvement.

Communication Guidelines

Students are required to attend official office hours (at least the first week to have your occupation approved) via ZOOM (or in-person if that is an option for you on Mondays or Wednesdays) and to contact the instructor when there are questions or concerns. Not attending any office hours may result in 5-10 points taken off from participation points. If my office hours are not suitable, feel free to contact me during regular business hours. Please use e-mail (UF or Canvas- either are acceptable) or phone. I will contact you promptly within 8am-5pm on weekdays.

Recording Within the Course:

Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. Publication without permission of the instructor is prohibited. To “publish” means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
